Motion made by Shannon MacMurchy of the Edmonton Insurance Association for acceptance of the report as presented. Motion was seconded by Sara Granger of the Montreal Association of Insurance Women. There was no discussion. All in favour and motion carried.

Tracy Fata took an opportunity to prepare the members on how the Association Forum was going to be presented this year. Groups were divided into age demographics and each group were to proceed to the table with their age appropriate group following the nutrition break. Tracy discussed that the ideas/information generated at the forum should be a part of the 1<sup>st</sup> Vice President's duties as this would be helpful to the incoming President elect to use as their platform.

#### Nutrition Break was sponsored by the Toronto Insurance Women's Association from 10:15 am to 10:30 am.

#### Association Forum - Moderator Tracy Fata, B.Sc, FCIP, DRM

Tracy had prepared two documents for each age demographic group to discuss and provide feedback:

- -everyone was to rank each event of the AGM/Convention in order of importance to themselves
- -a slate of questions was provided to each group and were to be discussed amongst each group

The results of the forum were handed into Tracy Fata and she agreed she would compile the results for presentation to the membership on Saturday.

Madame President announced there were signup sheets for Fun Night to indicate what time you would like to leave the hotel and return to the hotel. She also reminded the members that the Exhibitors were set up so everybody should try to go and visit with them.

#### Constitution & ByLaw proposed changes:

## Change 1: Item 16. Dissolution of CAIW Add:

c) In the event that an Association is unable to meet the requirements of an active association but is not yet ready to dissolve, they may request their membership with CAIW to be suspended. Suspension will be for the period of one year, based on CAIW fiscal year. This will give the Association time to either continue as an active association or to dissolve as per item 16.(b). During the one year suspension term, annual dues to CAIW will be suspended. There will be no representation at the post-convention. Midterm or preconvention meetings. Insurance premiums will continue to be paid based on the prior year numbers.

#### **RATIONALE:**

As we have seen the dissolution of many associations over the years, it would be opportune to provide one year's grace for associations to regroup. By giving this opportunity, the hope is the Association can rebound after one year and remain viable.

Motion was made by Dawn Mercier, Edmonton Insurance Association for acceptance of the change. Motion was seconded by Deb McDougall, Nova Scotia Insurance Women's Association. Discussion: Donna Payne had asked if no association then where does the membership dues come from. Response: did not take the membership dues just had the association pay for insurance. All in favour and motion carried.

## Change 2: Item 6a – Meetings Current:

- (a.) The Annual Meeting of the Association shall be held in June at the place designated at an Annual Meeting at least three years prior to such Annual Meeting. In the absence of bids, the choice of Convention site shall be made by the Executive Board. The Annual Meeting shall be composed of members of affiliated organizations, which have complied with Article III. Each organization shall be allowed two (2) voting delegates, if only one (1) delegate is present, she shall be allowed to cast two (2) votes.
  - i. The voting body shall consist of duly-accredited delegates or their alternates; however, all members of affiliated Associations may make motions and take part in the discussion at the annual meeting.
  - ii. The Executive Board shall meet immediately prior to the Annual Meeting.
- iii. There shall be a meeting of the newly-elected members of the Executive Board immediately subsequent to the Annual Meeting.
- iv. A Mid-Term meeting of the Executive Board including the Chairman of the Standing Committees will be held annually in January.

#### Proposed:

(a.) The Annual Meeting of the Association shall be held in June at the place designated at an Annual Meeting at least three years prior to such Annual Meeting. In the absence of bids, the choice of Convention site shall be made by the Executive Board. Notice of selection must be provided to the Local Association in writing. The Local Association chosen shall hold the right of first refusal, which can be executed within 90 days of its notice of selection in writing. The Annual Meeting shall be composed of members of affiliated organizations, which have complied with Article III. Each organization shall be allowed two (2) voting delegates, if only one(1) delegate is present, she shall be allowed to cast two(2) votes.

- i. The voting body shall consist of duly-accredited delegates or their alternates; however, all members of affiliated Associations may make motions and take part in the discussion at the annual meeting.
- ii. The Executive Board shall meet immediately prior to the Annual Meeting.
- iii. There shall be a meeting of the newly-elected members of the Executive Board immediately subsequent to the Annual Meeting.
- iv. A Mid-Term meeting of the Executive Board including the Chairman of the Standing Committees will be held annually in January.

Motion to accept was made by Donna Payne of the Newfoundland Labrador Association of Insurance Women. Motion was seconded by Shannon McMurchy of the Insurance Professionals of Calgary. There was no discussion. All in favour and motion was carried.

#### **Advisory Report**

Report was presented by Donna Brown. A meeting of the Advisory Board was held with all Past Presidents in attendance at Convention and the following items were discussed:

- CAIW should look at ways to shorten Convention/AGM
- Convention is not a fundraiser and sponsorship money is to be used towards Convention not to pass along to CAIW as a profit from Convention

#### **New Business:**

Madame President, Lynn Kelly, announced with regret that Mary Hooper from the London Insurance Professionals handed in their charter.

#### Budget 2015-2016 presented by Brenda Miller, CAIB, FCIP - Treasurer
