I'm sit here in disbelief that it's my final Presidents message of my first term. It's been a crazy but productive year. I have to extend my sincerest thanks to my Executive team. They have worked hard this year on NSIWA initiatives, and without them, we would not be successful.

As we finish up on the 2014-2015 term, let's recap what how we have been promoting our mandate of Education, Professional development and Networking.

Our marketing committee had a booth at the AAIB Convention in PEI on October 1st, 2014 – it was a well attended event and we created a lot of excitement about our Association – we earned 9 new members from the convention and have 3 more potential members coming from it. An absolute amazing way to raise awareness and presence of our Association. In turn due to the efforts of both this and the marketing committee we have 22 new members overall from last year. The membership chair has personally welcomed all new and existing members to the association, and is a driving force in our membership success.

It was no surprise that our Golf Day on September 12th, 2014 was again a sold out event. We had the pleasure of having CAIW President Tracey Fata attend our event. We had 144 golfers, all holes sponsored and donations of items for giveaways for after the event. A beautiful day overall. Photos of the golfers were taken and posted on our website, an email to each golfer followed with a link for them to view the photos. Our Annual Wine and Cheese was again a well attended event despite a snowstorm..over 775 attendees, it was our first time giving member priviledged pricing to an event, We will also be making a donation to Feed Nova Scotia with the proceeds of the Wine and Cheese.

Our Education chair lined up a stellar group of speakers for this year, we were motivated, educated and treated to a creative experience that engaged our membership. Our Education chair has also done some tabletop impromptus that encouraged all members to speak at the meetings. This engagement has created a feeling of familiarity within the group, and members commented on how much they enjoy the impromptus and the assigned seating as they are able to get to know others in the industry.

Our Insurance Information Campaign Week was October 20th to October 24th, 2014...We had our proclamation signed by the Mayor and a photo opp with him. His office tweeted about it along with the photo...we had a booth at the Sunnyside mall on October 23rd, 2014 talking to the public on Oil tank tips and maintenance. We had great participation from our members who volunteered at the booth. We had an Oil Tank Seminar on December 9th, with a panel of experts who discussed The Past, Present and Predicting Future of oil tanks..Overall an amazing campaign.

Our Ways & Means Committee has had monthly draws at our monthly meetings with gifts being generously donated by Avis Budget Group. We brought in 420 with our monthly draws so far to date . Our big fundraiser in December brought in a whopping \$3113 in ticket sales, all proceeds were donated to the Cancer Society. Our Christmas auction (with items generously donated by our members and industry partners) A list of those sponsors was given in our January Bulletin.

Our Public Speaking Contest was held in February, and Rebecca Burke – The Cooperators will represent us at Convention 2015. We cannot wait for her to compete. She will do us proud!!

The changes were presented to the Executive in December and posted in Decembers and Januarys bulletins and voted on at the general membership in January. 

Riverbank Discovery Centre



Home to Brandon & Regional Tourism Centre, Brandon Riverbank Inc. is located in the heart of the Assiniboine River Corridor. The Tourism Centre is open year round and contains information on the City of Brandon, the Southwest Manitoba region as well as Canada and the United States. The centre also offers souvenirs, RV parking & dump site, picnic areas and interpretive information on the natural beauty of the area.

Westman Reptile Gardens



Just a short drive east of Brandon you will find the Westman Reptile Gardens, one of Canada's biggest and best collections of exotic animals. They currently house over 15 different venomous snakes including various rattlesnakes, cobras, adders, vipers, and mambas. They have a world class collection of alligators, crocodiles and caimans. Snakes are one of their specialties. They have new world and old world ratsnakes, bullsnakes, kingsnakes, cornsnakes, milksnakes, pinesnakes, and

more! For the amphibian lovers they have lots of different frogs from poison arrow frogs to a huge African bullfrog! They have many, many different kinds of spiders and invertebrates as well as a variety of turtles and tortoises, lots of lizards from giant monitors to tiny geckos to beaded lizards! Oh, and who could forget the boas and giant pythons!





Commonwealth Air Training Plan Museum



The Commonwealth Air Training Plan Museum is Canada's only Air Museum dedicated solely to those who trained and fought for the British Commonwealth during 1939–1945 War. Explore this World War II Royal Canadian Air Force Training Site showcasing aircraft, artifacts and memorabilia. A National Historic Site, this museum is one of only six designated Manitoba Signature Museums and a Manitoba Star Attraction.

Riding Mountain National Park



Located approximately 100km north of Brandon, Riding Mountain National Park is an island of wilderness surrounded by a sea of farmland, boasting 3,000km² of rugged nature just waiting to be explored. Riding Mountain National Park is unique by the fact that it's one of only five national parks that has a resort town. Although small, the picturesque town of Wasagaming is big in charm and character.
