

In accordance to our Constitution & By-Laws

ARTICLE 3 – MEMBERSHIP

- a) An Active Membership is extended to:
- i) Any person engaged independently or through employment in any office, selling or servicing insurance of any type.
- ii) A member upon permanent retirement.
- iii) Any person, who has membership in any Local Association which is affiliated with the Canadian Association of Insurance Women or with the Association-At-Large and that membership is in good standing, may be entitled to automatic transfer privileges. "Good standing" means a member whose dues are currently paid to CAIW through an affiliated Association. NSIWA agrees to waive the duplicate payment of fees for a transferring member.
- b) An Associate Membership, without office and without vote, is extended to:
- i) Any person who has been a member of this Association or any affiliated association and who is no longer active in the insurance business.
- ii) Any person who has been a member of this Association but now lives too far away to attend meetings.

If you have any questions, please let me know. I look forward to seeing you all in September at our first general meeting being held at Brightwood on September 19th.

Motion made to accept the reports of the Local Association Presidents by: Katherine Toner, BA, LL.B.- New Brunswick Insurance Women's Association Motion seconded by: Lindsey Schroeder, BA, B.Ed, CIP – Edmonton Insurance Association All in favor: yes - no discussion, nays or abstentions – Motion carried The reports of the Standing Committees were given out prior to convention. There was an amendment to the Insurance Information Campaign. There is a possible sponsor – Wawanesa Insurance...Lee Huys, CAIB and chair of the Insurance Information Committee mentioned to them that we will need to know if they are interested or not as she will need to contact other possible sponsors.

Michelle Malo, FCIP notes that while the reports are great – we did only just get them, members did not have enough time to go over them – moving forward if we can please get them out at least two weeks in advance. That way everyone can read them and be prepared. Madame President stated that we will note it in the minutes and take it under advisement to ensure that we will adhere to this in the future.

The room was electric with conversation concerning the topics. Each team recorded their thoughts and 1 person from each team went to the mic and gave a snapshot of what was discussed. The conversation was very positive, ideas were given merit and Lori Penner told the crowd that she would compile all the the results and send back to the Associations.

Proposed Change 1

Constitution and Bylaws Page 6

Current Wording: 12. Duties of Officers

d. Treasurer

The books must be closed as at April 30th and audited in preparation for passing the books to the new Treasurer. The Treasurer shall deposit all funds of the Association to the credit of the Association in a bank approved by the Executive Board. Such funds shall be withdrawn only by cheques signed by the Treasurer and the President or Secretary of the Association. The Treasurer shall be chairman of the Budget and Finance Committee. No later than June 30th, the Treasurer shall deliver to their successor all funds, securities and records in their keeping.

Proposed Wording:

12. Duties of Officers

d. Treasurer

The books must be closed as at April 30th and audited in preparation for passing the books to the new Treasurer. The Treasurer shall deposit all funds of the Association to the credit of the Association in a bank approved by the Executive Board.

Such funds shall be withdrawn only by:

i) Cheques signed by the Treasurer and/or the President and/or 1st Vice President of the Association, with two of the three authorized signatures required at all times; or

ii) Electronic Money Transfer (EMT) by the Treasurer only after approval has been provided by the President following substantiation via receipts qualifying the expenses of the Officers &/or Directors. The Treasurer shall provide a copy of the EMT receipt to both the President and CAIW/ACFA Bookkeeper as confirmation of transaction.

The Treasurer shall be chairman of the Budget and Finance Committee. No later than June 30th, the Treasurer shall deliver to their successor all funds, securities and records in their keeping.

Rationale:

2 Payment via EMT is instantaneous. Therefore cutting down on the time it takes for the Treasurer to: make up a cheque, address the envelope and send payment

Recipient does not have to wait to receive a cheque. Treasurer does not have to wait until cheque is cleared to balance to account
 Cost of EMT transaction is roughly the same as a stamp from Canada Post (\$1.50 per)

1 It should also be stated as the EMT payment is only for Officers & Directors. Other payment(S) will be issued via cheque.

Instead of the secretary having signing authority, the 1st VP would have signing authority. In the event the President can't fulfill her duties, the 1st VP would be able to step in quickly to sign cheques and authorize payments.

② With the added check and balance of prior approval from President, the likelihood of a "questionable" withdrawal is practically nil.

Current wording:

8. Dues

a. Annual Dues

The annual dues of the CAIW shall be Twenty Five Dollars (\$25.00) per Regular Member, and Fifteen Dollars (\$15.00) per Member-at-Large and Associate Member. Dues shall be payable December 31st each year, based upon the membership of affiliated Associations as of that date. The fee for Members joining Local Associations after December 31st shall not be pro-rated. This fee per Member shall be submitted prior to our fiscal year end. Dues shall become delinquent unless payment is received by the first day of the Annual Mid-Term Meeting and delinquent Associations shall have no vote until delinquency is removed by payment of the dues plus a penalty of Two Dollars and Fifty Cents (\$2.50) per member. Delinquent Associations shall automatically be dropped from Membership March 1st. New Member Associations affiliating with CAIW shall have their dues waived until the next fiscal year of CAIW.

Proposed Change:

8. Dues

a. Annual Dues

The annual dues of the CAIW shall be Twenty Five Dollars (\$25.00) per Regular Member, and Fifteen Dollars (\$15.00) per Member-at-Large and Associate Member. Dues shall be payable December 31st each year, based upon the membership of affiliated Associations as of that date. The fee for Members joining Local Associations after December 31st shall not be pro-rated. This fee per Member shall be submitted prior to our fiscal year end. Dues shall become delinquent unless payment is received by the first day of the Annual Mid-Term Meeting and delinquent Associations shall have no vote until delinquency is removed by payment of the dues plus a penalty of Two Dollars and Fifty Cents (\$2.50) per member. Delinquent Associations shall automatically be dropped from Membership March 1st. New Member Associations affiliating with CAIW shall have their dues waived until the next fiscal year of CAIW.

In the event of dissolution and/or resignation of an Association, all membership dues paid are fully earned.

RATIONALE:

Adding this sentence provides that any Association leaving CAIW will not receive a rebate of membership dues Motion made to accept by: Lindsey Schroeder, BA, B.Ed, CIP – Edmonton Insurance Association

Proposed Change 3

Constitution and Bylaws page 5

Current wording:

10. Nomination and Election of Officers

b. Section II

The Officers of the Association shall be elected annually by a plurality vote of the certified Delegates present and voting at a business session on the last day of the Annual Meeting. If the Annual Meeting cannot be held, election shall be by mail. No two Officers shall be from the same Association. No two offices shall be held by the same person. All elections shall be by ballot unless there is only one nominee for office, in which case election may be by acclamation.

In the event of a tie between the two leading candidates for an office in an election held at an Annual Meeting, a second ballot shall be taken. Should the tie remain unbroken after the second ballot, the successful candidate shall be determined by lot, conducted by the Chairman or another member of the Nominating Committee.

In the event of a tie between the two leading candidates for an office in an election by mail, there shall be no second ballot, the successful candidate being determined by lot, conducted by the Chairman or another member of the Nominating Committee, in the presence of at least one other member of the Committee.

The term of office, which begins at the close of the Annual Meeting at which the election is held, or, in the case of a mail ballot, on the date the result is announced, shall be one year or until successors are elected. An officer may not hold the same office for more than two consecutive terms.

Proposed Change:

10. Nomination and Election of Officers

b. Section II

The Officers of the Association shall be elected annually by a plurality vote of the certified Delegates present and voting at a business session on the last day of the Annual Meeting. If the Annual Meeting cannot be held, election shall be by *email*. No two Officers shall be from the same Association. No two offices shall be held by the same person. All elections shall be by ballot unless there is only one nominee for office, in which case election may be by acclamation.

In the event of a tie between the two leading candidates for an office in an election held at an Annual Meeting, a second ballot shall be taken. Should the tie remain unbroken after the second ballot, the successful candidate shall be determined by lot, conducted by the Chairman or another member of the Nominating Committee.

In the event of a tie between the two leading candidates for an office in an election by *email*, there shall be no second ballot, the successful candidate being determined by lot, conducted by the Chairman or another member of the Nominating Committee, in the presence of at least one other member of the Committee.

The term of office, which begins at the close of the Annual Meeting at which the election is held, or, in the case of a mail ballot, on the date the result is announced, shall be one year or until successors are elected. An *Officer* may not hold the same office for more than two consecutive terms.

RATIONALE:

It is unrealistic to expect voting to be conducted by snail mail when email is a more viable method at this time. Also the capitalization of the "O" in Officer is just housekeeping.
